5th JOINT MONITORING COMMITTEE MEETING

20th & 21st June 2019

Venue: Hotel Tomori Berat, Albania

Brief Minutes & Decisions

The Joint Monitoring Committee (hereinafter referred to as JMC) of the Interreg IPA Cross-Border Cooperation Programme "Greece-Albania 2014-2020" convened for its 5th Joint Monitoring Committee Meeting on June 20th and 21st, 2019 in Berat, Albania, following an invitation by the Hellenic Managing Authority of European Territorial Cooperation Programmes (hereinafter MA of ETCP), in agreement with the co-chairs.

Mrs Daniela Cekani, Director of the Department for EU Funds of the Ministry for Europe and Foreign Affairs, who is Chair of the Committee, welcomed the participants, wished a fruitful 5th Joint Monitoring Committee Meeting.

The Chair then passed the floor to Ms Dominic Zaralidou, Legal Advisor to the Special Secretary of ERDF & CF funded sectoral Ops, Ministry of Economy & Development, who substitutes Ms Evgenia Fotoniata, Special Secretary of ERDF & CF funded sectoral Ops, who is co-Chair of the Committee, welcomed the participants and wished a fruitful 5th Joint Monitoring Committee Meeting.

The floor was then passed to Ms Nadine Lakhal, Programme Manager of the European Commission, who welcomed the members and wished a successful meeting.

A different order on the topics of the agenda was proposed by the chair and adopted by the members of the JMC. The chair confirmed that quorum was achieved, asked all members of the Joint Monitoring Committee to sign a Declaration of Impartiality and Confidentiality, requested that the draft agenda is adopted and opened the 5th Joint Monitoring Committee Meeting.

The Chair then passed the floor to Ms Katia Sagona, Head of Unit B2 of the Managing Authority, who presented the Programme's State of Play.

Mrs Mavria underlined the fact that the closing procedures have been initiated and the respective guidelines are expected to be completed.

She also mentioned the potential of a future Programme modification should take place, since the end of 2020 is the last year for such a procedure according to the Regulation.

According to the proposal by MA/ JS, such a modification is not necessary, as justified by the presentation and included in the State of Play document. The MA asked the representative of the European Commission, Mrs Lakhal for an official reply on the issue.

Mrs Lakhal stated that she will reply after consultation with the European Commission. The respective request will be send to Mrs Lakhal by the MA, in order to receive an official written reply.

The Chair passed the floor to Ms Popi Evgenidou, Financial Officer of the Joint Secretariat, who presented the evaluation procedure of the 4th Call for project proposals, the Concept Note and the outcome of the assessment.

Extensive discussion took place on the 4th Call evaluation results.

Ms Kalogirou, Officer of the Executive Unit for the Partnership Agreement for the Development Framework 2014-2020 of the Hellenic Ministry of Culture and Sports asked that some conditions at the file condition - recommendation for the projects AUTHENTIKK, i-THEA and MILESTONES III are added. Regarding the project i-THEA all the necessary licences and approvals by the competent archaeological service should be requested before signing the subsidy contracts and it should be ensured that there is no overlap with any other similar project financed by the ROP of Epirus. Regarding the projects AUTHENTIKK and MILESTONES III, all the necessary licences and approvals by the competent archaeological service should be requested before signing the subsidy contracts.

Mr Papadopoulos mentioned that these requirements will be included in the file "Conditions-Recommendations" of the specific projects.

Mr Mourouzis, Representative of National Confederation of People with Disabilities asked for statistics and input on how the projects approached the criterion on the accessibility. Mr Papadopoulos replied that all projects were found compatible with the respective criterion during the first phase evaluation of the proposals.

Mr Xhaxhiu, Head of the Territorial Cooperation Programming Unit of the Ministry for Europe and Foreign Affairs proposed more projects to be included under SO2.1 arguing the importance of tourism projects in the eligible area of the Programme. The proposal was supported by Mrs Zaralidou and the JMC agreed that two (2) more projects will be included in the list of the projects to be funded, SMARTOUR & GET.

Mrs Kalogianni, Representative of the ENPE, suggested horizontal budget reduction of 30% in SO2.1 in order more projects from the reserve list to be included for funding. Discussion took place and finally this proposal was not accepted.

Mr Papadopoulos underlined that the eligibility check for the project beneficiaries will take place after the JMC meeting. In case of ineligible beneficiaries, the project will be rejected in total and the reserve list will be activated respectively.

The Chair then passed the floor to Mr Prodromos Vadratsikas, private consultant responsible for the First Evaluation of the implementation and impact of the Interreg IPA Cross-border Cooperation Programme "Greece-Albania 2014-2020", who presented the Final Evaluation Report.

The MA asked the confirmation by the JMC members for the participation on the continuation of the meeting on the 21st of June 2019, in order for the

quorum to be achieved for the approval of the AIR, Capitalisation Strategy and the Modification of the TA Multiannual Plan.

At this point the JMC meeting was ceased for the day.

The meeting continued on 21st June 2019.

The Chair confirmed the quorum and the meeting was initiated.

The floor was then passed to Mr Vasilis Charitantis, Officer of the Managing Authority Unit B2, who presented the Annual Implementation Report for 2018. Following the approval by the JMC, the AIR will be submitted via SFC to the EC.

Mrs Lakhal informed the JMC members on the special exercise of this year's Performance Framework.

The Chair then passed the floor to Ms A. Koktsidou, JS Communication Officer, who presented the Capitalization Strategy of the Interreg IPA Cross-border Cooperation Programme "Greece-Albania 2014-2020".

Mr Xhaxhiu requested for targeted and analytical presentation on Capitalisation issues and JMC members agreed.

Ms Koktsidou also presented the Modification of the Technical Assistance Multiannual Plan. Following the approval by the JMC, the Albanian beneficiary of the Technical Assistance will submit to the Joint Secretariat via the MIS the modified Application Form.

Following the discussions, the Joint Monitoring Committee (JMC) decides unanimously to approve as presented by the MA/JS:

- ➤ the Capitalization Strategy
- > the Modification of the Technical Assistance Multiannual Plan
- > The Annual Implementation Report for 2018
- > The projects for funding under the 4th Call for Project Proposals are:
 - o 6 projects under SO1.3
 - o 13 projects under SO2.1
- > A reserve list of 9 projects under SO2.1
- The overbooking of the Programme's budget as it will be finalised after the signing of the Subsidy Contracts.

> The indicator regarding SO1.4 will be covered through the 5th targeted

call with a budget of 2,5 million euro.

The JMC authorises the JS to proceed with the budget clearing for the 2 additional projects that were included for funding.

Following the approval of the projects, the Complaint procedure will be initiated. The closing of the Complaint procedure will be followed by the Beneficiaries' eligibility check. The list of the project proposals approved for funding will be finalised after the completion of both aforementioned procedures.

The list of the approved projects under each Specific Objective, the list of reserve list under Specific Objective 2.1 and the list of rejected projects are presented in the annex, which is an integral part of the 5th Joint Monitoring Committee meeting decision.

At the end of JMC meeting, Brief Minutes and Decisions were drafted by the MA/JS and the Chairperson read them out to all JMC members to comment.

Finally, the document was signed by the two co-chairpersons.
